MATCH DATES

The default date for matches in the Preliminary Round is Saturday 23 August 2025, kick-off 3.00pm.

There are no replays. When a match is drawn after 90 minutes, the winner shall be determined by the taking of kicks from the penalty mark in accordance with the procedure adopted by The International Football Association Board.

If a match is postponed, this must be rescheduled and played within the postponement window, on or before Thursday 28 August 2025.

MATCH ARRANGEMENT FORM

Match Arrangement Forms will be available on iFAS in due course. Clubs will be notified by email once these are available for completion.

PLAYER REGISTRATION DEADLINE

The Player Registration Deadline is **12 noon on Friday 22 August 2025** irrespective of the date the match is played.

GROUND SHARING

Clubs with ground sharing agreements must arrange for ties to be played on Friday, Saturday or Sunday. If a clash of fixtures occurs with the sharing Club or other sport, if for any reason a match is unable to be played on the ground of the first drawn Club on the default date, it must be played on either the day before, i.e. on Friday, or the day after, i.e. on Sunday on the ground of the first drawn Club. If Clubs are unable to agree on the date, the match would then default to the Sunday, unless decided otherwise by the National Game Board.
