MATCH DATES

The default date for matches in the Second Round Qualifying is Saturday 19 September 2026, kick off 3.00pm. Replays are mandatory if a first match is drawn after 90 minutes. Replays must be scheduled on or before Thursday 24 September 2026, kick off 7.45pm.

If a first match is postponed, this must be rescheduled and played on or before Thursday 24 September 2026. If a replay is postponed or delayed due to the postponement of a first match, this must then be scheduled and played on or before Thursday 1 October 2026.

MATCH ARRANGEMENT FORM

Match Arrangement Forms will be available on MOAS in due course. Clubs will be notified once these are available for completion.

PLAYER REGISTRATION DEADLINE

The Player Registration Deadline is **12 noon on Friday 18 September 2026** irrespective of the date the match is played.

GROUND SHARING

Clubs with ground sharing agreements must arrange for ties to be played on Friday, Saturday or Sunday. If a clash of fixtures occurs with the sharing Club or other sport, if for any reason a match is unable to be played on the ground of the first drawn Club on the default date, it must be played on either the day before, i.e. on Friday, or the day after, i.e. on Sunday on the ground of the first drawn Club. If Clubs are unable to agree on the date, the match would then default to the Sunday, unless decided otherwise by the Professional Game Board.

Guidance

If two Clubs party to the same ground sharing agreement are scheduled to play a Competition Match at home on the same date, the Club playing at the higher level of the National League System will be deemed to have priority of fixture, unless the ground share agreement states otherwise or The Association directs otherwise.
